If you are boating from an alternative location, please obtain permission from the host club and inform the events secretary of where you intend to boat from.


Please park cars in Logan's Way (giving due consideration to neighbouring establishments) - do not park in the compound (this is to allow space for trailers and boats). The compound will be open from 08:30 on race day.

At the Elizabeth Way roundabout (at the end of Chesterton Road on the north side of the River Cam) take the 2nd exit past Elizabeth House (CATS building) heading to Chesterton High Street. Take the first right into Church Street, follow the road (flows into St Andrews Road) and go past St Andrews Church on your right, pass the large white office building (St. Andrew's House) and the Sepura offices (wavy roof). Take the next left into Logan's Way, passing an office car park on your left, and continue to the end of the road - the combined Colleges boathouse/CRA boathouse compound is through the gates. For visiting cars, please park outside the compound to allow vehicles with trailers to park. Trailers may have to be parked on the roads surrounding the site following unloading.

BOATING PERMISSION FORM

The Combined Colleges are: Selwyn College, Kings College, Churchill College and the Leys School.

The Champs Events Secretary has signed the Permission Form as Organiser, each visiting Club must also confirm that they agree to the conditions below. Queries should be addressed in the first instance to Champs Events Secretary: champsiuniorhead@gmail.com

Clubs, schools and organisations using the Boathouse or the land belonging to the Boathouse must agree to the following terms and conditions:

- 1. Users must have their own insurance for their own equipment and any equipment they use which belongs to the Boathouse or to the College clubs which are members of the Boathouse. All users must have insurance in place equivalent to British Rowing insurance.
- 2. Selwyn College, King's College, Churchill College and the Leys will not accept any liability for any personal injury, loss or damage incurred on the premises of the Boathouse or its surrounding land.
- 3. Users must obtain permission from the Combined Colleges by completing this form before using the premises or the land. Permission should be sought by returning the form to the Operations Manager, Selwyn College, after <u>first</u> consulting the Supervior. On each occasion that use of the premises or land is made, permission must be sought at least 7 days in advance.
- 4. The combined colleges reserve the right to levy fees in respect of the use of the facility. Any damage will be charged for.
- 5. Users must leave the premises and land in a clean and tidy state and depart promptly after races have ended, taking any rubbish with them.
- 6. Vehicles will be parked outside the Boathouse compound, with due consideration to neighbouring establishments, and users are responsible for ensuring that the Boathouse (if used) and the entrance gate are locked on departure.
- 7. Users must ensure that their rowers/members are properly trained in the use of any equipment on the site and that unnecessary risks are not undertaken, also that boats used on the site are properly licensed and obey the rules of the river.
